EXHIBIT TABLE-TOPS:

Rental space will consist of one 6' draped table, two chairs, a company sign, and one waste basket. No attachments shall be made to any part of the exhibit area without express permission of AGIAC. No banners, posters, or signs may be erected which in anyway interfere or distract the view, light or space of any other exhibitor. Advertising material or signs of firms other than those who have engaged space is prohibited.

TABLE-TOP COST:

First table-top, \$ 1000.00, Second table-top, \$ 850.00, Third and subsequent booth, \$ 700.00

EXHIBIT SPACE LOCATION:

Grand Ballroom Foyer area, all exhibits will be located in the designated exhibit area. There will be no displays permitted outside the official exhibit area unless authorized by AGIAC.

DELIVERY OF SHIPMENTS:

The Disneyland Hotel will accept delivery of boxes and store them on behalf of AGIAC, 3-days prior to the conference (on or after Friday, July 29, 2011) until the start of the conference. SUBLEASING: Exhibitors may not sublet their space, nor any part thereof.

PAYMENT OF TABLE-TOP RENTAL FEES:

A deposit of fifty (50) percent is required at the time of your application. Payment of the remaining balance is due no later than July 1, 2011. If total payment is not received by July 15, 2011, AGIAC reserves the right to cancel the space requested by the exhibitor and all arrangements will be considered void.

CANCELLATION OF EXHIBIT SPACE:

A non-refundable fee of \$ 300.00 will apply to any reservation of space cancelled less than 30 days before the start of the exhibit time.

DISPLAY SPACE NOT CLAIMED: Space not occupied or claimed by 1200 hrs on August 1, 2011 may not be cancelled or reassigned without approval of AGIAC.

GUARD PROTECTION:

Security will be provided during exhibit hours, but not after hours. Any type of valuable items can be stored in the storage room until the next following morning prior to the opening of the exhibit area. However, AGIAC cannot be responsible for, or guarantee against any losses.

LIABILITY:

The Exhibitor agrees that if a table top is rented, that the exhibitor accepts all terms that is listed below in this agreement. The Exhibitor agrees to provide proof of insurance to AGIAC during the dates of the Event, and during any other times in which any of the exhibitors are on the property of the Disneyland Resorts, also:

"The exhibitor assumes all responsibility for any and all loss, theft and/or damage to exhibitor's displays, equipment and other property while on *Disneyland*® Resort premises, and hereby waives any and all claims and/or demands it may have against the Asian Gang Investigator's Association of California and the Walt Disney Parks and Resorts, LLC, its parent and/or any of its affiliate companies arising from such loss, theft and/or damage.
